COOK REPORT - LIBEL ACTION AGAINST CENTRAL TV

- Following our discussions earlier this month about a response to meet the Secretary of State's commitment to provide some information about funding for nationalist groups, I consulted Departments about support for community organisations in "catholic West Belfast".
- 2. I have attached copies of the information provided by DOE and DED setting out the levels of support for community organisations and through schemes like YTP, JTP and ACE. In addition to these programmes MBW colleagues estimate that through other programmes, where the information is slightly more difficult to disaggregate, somewhere in the region of another £3-£4m might be allocated to community organisations in catholic West Belfast in 1991/92.
 - When you have had an opportunity to consider these figures we should have a discussion about their presentation to Central TV.
