BRIEFING FOR PRESS OFFICE

Q. Why is the Secretary of State delivering this speech now to an Orange Lodge?

Is there any significance in the timing of this speech?

A. The invitation is of long standing and the date was arranged long before recent developments.

The Secretary of State received an invitation in May to address members of Comber District Orange Lodge. He considered that it was important to take the opportunity to explain Government policy.

- Q. Is this the first time that the Secretary of State has addressed members of an Orange Lodge?
- A. Yes, although like his Ministerial colleagues he has met with senior representatives of the Grand Lodge in Ireland from time to time to discuss matters of mutual interest. Also, the Grand Master of the Grand Lodge (Rev Martin Smyth) is a Parliamentary colleague.
- Q. Will the Secretary of State be speaking to any other Orange Lodge?
- A. We are not aware that the Secretary of State has received any other invitations from an Orange Lodge. But if such an invitation were received, the Secretary of State would of course consider it.

- Q. Would the Secretary of State be willing to speak to an equivalent nationalist/catholic organisation such as the Ancient Order of Hibernians?
- A. If the Secretary of State received such an invitation, he would of course consider it.
- Q. Has the Secretary of State ever received such an invitation from an equivalent nationalist organisation?
- A. Not as far as we are aware.
