- In light of the increasing number of invitations issuing from the Forum for Peace and Reconciliation, I felt it would be useful to provide guidance to Departments on how to respond to these.
- 2. At the present time, it is not considered appropriate for Ministers or officials to accept invitations to participate in the Forum. If such invitations are received by Heads of Boards it is a matter for the individuals concerned to decide whether or not to accept. However, participation by Heads of Boards, whether orally or through submission of papers, must be qualified by a rider that the views expressed do not necessarily reflect those of the Government.
