I take great pleasure in inviting you to attend a one-day conference, which is being held by the European Parliament in close co-operation with the European Commission, entitled "Implementing Europe's Programme for Peace". The Conference is being held thanks to the joint initiative taken through the Regional Policy Committee by the three MEPs who represent Northern Ireland and will demonstrate their commitment to its success. The Conference, which will host 400 decision-makers from both the public and private sectors, will take place on Tuesday 11 April in the Balmoral Conference Centre, Belfast.

As you are aware, the European Parliament is currently considering proposals from the European Commission for a Special Support Programme for Peace and Reconciliation in Northern Ireland. This is designed to make available to Northern Ireland and the border counties of the Republic of Ireland a package of aid worth 300 million ECUs (approximately £240 million) in the period 1995-97, with perhaps more to follow over the two years beyond that. The five recommended priorities of the package are: employment; urban and rural regeneration; cross-border development; social inclusion; and investment and industrial development.

This initiative is unique in two respects, which the Conference aims to reflect. It is genuinely additional to existing EU and national funding and it will rely heavily on the input and support of grass-roots organisations. The Conference will bring together on the one hand those at European level - the Members of the European Parliament, especially the Regional Policy Committee, and MEPs from Northern Ireland and the border counties, and representatives of the European Commission - who are responsible for the shaping and early application of the Programme and, on the other,

representatives of those authorities and organisations at national and local level who will be called upon to co-operate in its implementation. The Conference will thus help to put the finishing touches to the package and to inform local organisations about the practical details of how the special support will be channelled.

I hope that you will be able to take part and I look forward to welcoming you on the 11th April.
