SUB-PROGRAMME 3: CO-OPERATION BETWEEN PUBLIC BODIES

I am responding to your minute of 4 June on the above subject. As far as DED is concerned the information you seek is as follows:

- (1) NITB have submitted 3 proposals under Measure 3. These are:
 - An integrated marketing proposal under Measure 3

£670,000

 A Border Towns Marketing Scheme (involving third parties)

£160,000

- Development of the Gulliver computer reservation system

£300,000

£1,130,000

- (2) While we have indicated our broad support to NITB as yet the above proposals have not been formally approved and a letter of offer has not issued. We hope however to announce a package of tourism projects under the Special Support Programme (possibly including the above projects) later this month. This of course is dependent upon the ROI authorities endorsement of the cross-border tourism projects.
- (3) No other applications have been approved in principle and no formal communication indicating approval in principle has, as yet, issued to NITB.
- (4) We are not considering any other applications under this particular Measure. In effect the three NITB projects referred to above will fully take up our provisional allocation under the Measure.

Guidance Notes for Applicants

Sub-Programme 3: Cross-Border Development

Measure 3 (A) Cooperation between Public Bodies of the Special Programme for Peace and Reconciliation

(These Notes should be read together with the General Guidelines for the peace programme)

1. Measure Objectives and Rational

The objectives of this Measure are to release further synergies in the provision of public services through co-operation between public bodies leading to an improvement of services in the interests of the border communities. The Measure seeks to encourage and support cooperation and the adoption of co-ordinated approaches by public bodies to common problems in the eligible areas of Northern Ireland and the Border Counties of Ireland which are of significant importance in both social and economic terms. Therefore, projects submitted for assistance should either initiate, or develop cooperation North and South to a significant new extent.

2. Funds available

Measure 3 (A) has provision for a total expenditure of 10,834 MECU (5,417 MECU each North and South). The EU funding element will derive from the Regional Fund.

3. Potential project areas

The Special Programme lists on an indicative basis the types of actions which might be funded. These include the following:-

- co-operative arrangements between agencies North and South on environmental research and development;
- co-operative arrangements between Health Boards and Health and Personal Social Services Agencies;
- co-operative arrangements between local authorities;
- integrated marketing of the eligible area;
- co-operative arrangements between education and training providers.

4. Nature of applicants

Applicants and delivery mechanisms are envisaged to be Government Departments, statutorily established public bodies and other relevant bodies providing a public

service as determined by both Governments.

5. Financial Support Available

Support is provided in the form of a discretionary grant. Projects may attract aid of up to a maximum of 75%.

6. Project selection criteria

Projects submitted for consideration under this Measure should lead to increased cooperation and improvement in the provision of services. In their consideration of projects, the joint Programme Managers will require clear evidence that projects submitted are jointly planned and intended to be jointly executed by two or more public bodies (unless operated by mutual agreement under licence/agent basis by one such body) and are capable of joint funding, North and South.

Preferential regard will be given to projects which are likely to promote sustainable cooperation and interdependence and are not covered by existing European Union or other Programmes.

In evaluating projects the Programme Managers will take account of:

- (I) Programme Objectives projects must demonstrate that they contribute to the strategic objectives of the Peace and Reconciliation Programme.
- (ii) Measure Objectives projects must demonstrate that they contribute to the objectives of the Measure.
- (iii) The extent to which the project initiates or develops co-operation between public bodies. This will be the primary factor taken into account in deciding on applications.
- (iii) Additionality that funding is not being diverted elsewhere or activity would not otherwise be undertaken.
- (iv) Viability evidence that the resources and expertise needed to bring the project to fruition with grant assistance are available from either internal sources and/or external sources.
- (viii) Project management evidence that the project will be effectively managed.

7. Application Procedure

This measure is being managed for Northern Ireland by the Department of Finance and Personnel and in Ireland by the Department of Foreign Affairs in cooperation with the Government Departments directly responsible. The project applications will be evaluated taking full account of the views of all Departments concerned especially where projects from non-Departmental bodies are concerned.

Applications should be jointly agreed by the Public Bodies in the two jurisdictions and completed application forms submitted to the parent Central Government Department for forwarding to the programme managers.

Applications should be submitted before (September 15) and the outcome of the evaluation process will be made known by (mid December 1996).

The decision of the Programme Managers is final.

8. Project Approval

- (I) LETTER OF OFFER: If the project application is successful, the Programme Managers will issue a formal joint letter of offer specifying the amount of support and any conditions which may apply.
- (ii) **CLAIMS:** Payment arrangements will be those normally applied to ERDF grants by the appropriate government departments.
- (iii) PROGRESS Reports: As required by Parent Government Departments who will also be required to keep the programme managers informed
- (iv) POST COMPLETION EVALUATION: As required by Parent Government Department in consultation with the Programme Managers.

 In addition, the European Commission will be carrying out its own monitoring and evaluation of the Special Programme and Groups receiving assistance under the Programme may be required to co-operate with the European Commission in such evaluation.
