### IMPLEMENTATION BODIES: LETTER FROM GERRY ADAMS TO THE PRIME MINISTER

You asked for advice on John Sawers' letter of 3 March, enclosing a letter to the Prime Minister from Gerry Adams. Adams was concerned that the UUP were negotiating assurances that if the Assembly fell, so too would the implementation bodies.

2. This issue was dealt with in the drafting of the Treaty establishing the first six implementation bodies. The Treaty does no more than reflect the language of the Agreement. The Preamble quotes the section from the Agreement which describes the new institutions as interlocking and interdependent. We can therefore deal with Mr Adams' concern by a simple reference to the way that the Treaty has been drafted.
