For part of meeting

A plenary meeting of Strand One of the Talks took place at Parliament Buildings between 16.10 and 17.11 on 19 June.

- 2. The <u>Government Team</u> was led by its deputy for the first 15 minutes of the session.
- Before substantive discussion began, the SDLP asked the 3. Government Team through the acting Chairman, to withdraw an earlier statement which they had made concerning an article in The comments attributed to that day's copy of the Irish Press. totally inaccurate which alleged "SDLP source" were confirmed that the source could not have been SDLP The Government Team noted this. delegate.
- 4. During <u>Alliance Party</u> clarification of the UDUP presentation, the following main points were made:-
 - (i) page 2, paragraph 1: The statement "The IRA cannot be defeated by political measures alone" represented the UDUP's considered position that

other factors such as enhanced security measures were more important in the defeat of terrorism.

- (ii) page 3, paragraph 2: The term "the Roman Catholic
 IRA" was simply a reflection of how the UDUP viewed
 the Roman Catholic church's position on Republican
 terrorists. This was not the same as the
 Protestant church's view of Loyalist violence.
- (iii) page 3, last sentence: The <u>UDUP</u> confirmed that they were concerned about the present status of some of the agreed positions having been entered into with both Governments at the beginning of the process. One such example given was the disclosure of the timing of Sir Ninian Stephen's introduction as Chairman which suggested to the <u>UDUP</u> that timetabling decisions had already been taken on a different basis to those originally agreed.
 - (iv) page 5, paragraph 2: The <u>UDUP</u> confirmed that the term "foreign government" was being used in the legal and the colloquial sense, accepting that for the purposes of certain UK legislation the Republic was not <u>treated</u> as a foreign country.
 - pages 10-11: (First paragraph of indented quotes). (v) The UDUP confirmed that they could accept statement presented by the Secretary of State on description of 5 July as an accurate constitutional status of Northern Ireland, (though they did not accept the later thought that Articles 2 and 3 of the Irish Constitution should not be a major preoccupation). In analysing the phrase "the principles of democracy and self-determination", the <u>UDUP</u> confirmed that it was "the people" Northern Ireland (as a body) and only they who should decide the future status of the Province.

- (vi) page 14, paragraph 2: second sentence. The <u>UDUP</u> confirmed that they, as a party, were looking for significant structural developments in terms of the highest form of devolution available, including security powers.
- Page 17, paragraph 1, ninth In (vii) sentence. presenting clarification on the phrase "including its proposed institutionalised Council of Ireland" the UDUP stated that further proposals would be tabled which would develop this theme. However, the UDUP believed that any such structure must be formed by elected representatives in a devolved administration rather than individuals appointed or imposed by a sovereign government. In further discussion of the phrase "ill-fated Power Sharing As-of-Right Executive", the <u>UDUP</u> acknowledged that this did not necessarily imply an objection to power-sharing by virtue of a voluntary coalition.
- (viii) page 22, final paragraph: The <u>UDUP</u> confirmed their position that certain powers would need to be given over to any new structure over and above those which the present Government might be willing to offer.
- The Government Team, in bringing the session to a close, 5. referred to a number of outstanding procedural issues. confirmed that the first session on 24 June would provide an opportunity for the SDLP to seek clarification of the UDUP position paper. Secondly, in reference to the Renewal Debate the House on the following day, the Government Team commented that they saw some value in those present saying less rather than more about the present phase of Talks. Press statement covering the events of the day was agreed.
- 6. The <u>UDUP</u> commented that they were most unhappy about attempting to hold the content of their position paper over the

weekend, given the prospect of concerted media attention etc. After a brief discussion it was agreed that delegations should be free to publish their own presentations.

- 7. The <u>SDLP</u> then returned to their opening remarks about the Irish Press article and sought a withdrawal of earlier comments made by the <u>Government Team</u>. The <u>Government Team</u>, following further consideration of the issue, accepted the point made but said it was largely a matter between the Party and the author of the commentary.
- 8. On a final point, the <u>UDUP</u> raised the question of intensifying the Talks process, and sought clarification as to why it was not possible to work on and extend the current session. The <u>Government Team</u> referred the UDUP to an earlier decision of the Business Committee which had agreed to an intensification of the process the following week.
- 9. The <u>Government Team</u> concluded the session by inviting everyone to be present at 10.30 am on 24 June to continue the business in hand.
