
**EU PEACE AND RECONCILIATION PROGRAMME: COMING EVENTS

## COMING EVENTS CALENDAR

## Guidance on completing the form

1. The form indicates the 3-monthly period for which information is required. Each entry should indicate the date of the event. Entries which are provisional should be denoted with an asterisk (\*).
2. Entries should be made for any events which promote the Peace Programme or announce projects etc under the Programme. Types of event which should be included are:-
  - Press announcements: these should include formal announcements of projects approved for funding. In many cases these will not be identified individually but particular mention should be given to projects or schemes of particular note or importance.
  - Publicity events - eg publication of information leaflets, roadshows.
  - Launching/opening of projects assisted under the Programme.
  - Conferences, Seminars etc.
3. Details of the involvement of Government Ministers in any event should only be included if this has no security implications. In completing the schedule you should bear in mind that it will be circulated widely outside Government.
4. On receipt of the returns DFP will co-ordinate all the coming events into a schedule by date order. This will normally be available one week after the deadline for receipt of returns.
